The Bursar, Mr. Mufutau Bello urged the Directors of the bank to look beyond the University staff and tap from the huge population of Bosso Community.

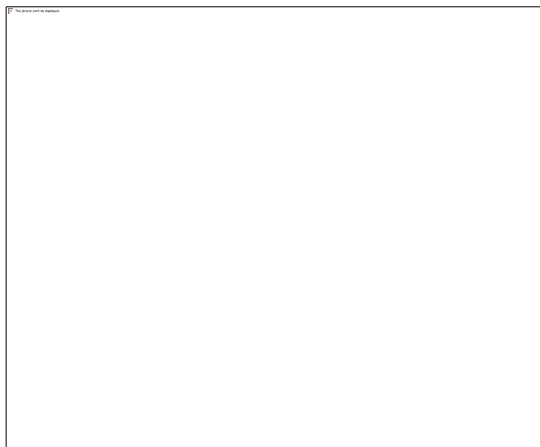
The bank got operational license on March 8, 2012 with a share capital deposit of N20m.
