# **UNIVERSITY SECURITY WINS 2018 VC CUP** Prof Bala Commends University Sports C'ttee

he University Security Services football team concluded their superlative performance in the 2018 Federal University of Technology, Minna Inter-School/Department/Unit Staff Football Championship with a hard fought 2-1 victory over the University Registry Department to win the maiden edition of the competition played on Wednesday, April 25, 2018 at the University Football Field, Main Campus.

Two first half goals from Sani Yakubu and Abraham Peter in the 11<sup>th</sup> and 23<sup>rd</sup> minutes saw the University Security Services lift the coveted trophy. The University Security team dominated the first half of the keenly contested encounter watched by a large number of spectators and they made the possession count with two beautifully taken goals that were greeted by rapturous celebration by their supporters. The Security Boys held on to their two goals advantage to end the first half in the driver's seat.

The Registry Department took over proceedings in the second half after receiving pep talks from the technical adviser of the team, Mal. Aliyu Abubakar and the University Registrar, Mrs. Victoria Nnawo Kolo during the half time break. The instructions paid off as the Registry Department team came all out in the second half and created several goal scoring opportunities but lacked aplomb and cutting edge in front of the University Security team's goal post.

The pressure from the Registry Department later paid off in the 53<sup>rd</sup> minutes when their star player Ahmed Adamu was brought down in the penalty box and the centre referee wasted no time in awarding a penalty kick which was calmly converted by Ahmed Adamu to set up a tensed final moment. The University Security Services held on despite the countless attacking moves by the Registry Department to maintain the 2-1 score line to clinch the trophy.

Despite starting the championship as hot favourite, the University Security Services laboured to defeat School of Agriculture and Agricultural Technology 1-0 in their opening match. However, the team grew stronger as the tournament progressed, impressing spectators with their free flowing style of football that produced 21 goals in five matches before the final without conceding a goal.

The Registry football team also amassed 15 goals before the final match and their strikers were curtailed by the University Security Services defenders.

The Vice-Chancellor's Office team came third in the championship after overcoming Physical Planning and Development Unit/ Works football team 1-0 in the thirdplace match.

Speaking before presenting the trophies, the Vice-Chancellor of the University, Prof. Abdullahi Bala, FSSSN congratulated the University Security football team for winning the championship and the Registry Department for being the second best team of the championship, adding that the final match and the competition generally lived up to its pre-tournament hype.

"We now know the Ronaldos, Maradonas and Messis of FUT, Minna," the VC disclosed.

Prof. Bala stated that the championship has achieved its aims and objectives of building the bond of friendship among staff of the University as well as spotting new talents that would represent the University at the forthcoming Universities Staff Games scheduled to hold at the University of Ilorin later this year.

"I believe that when we go for the University staff games, we will come back with gold medal in football," Prof. Bala enthused.

The Vice-Chancellor commended the University Sports Committee for organizing the championship and also thanked all players and officials that participated in the championship while urging teams to prepare better for the next edition so that they can win trophies.

Earlier in his address, the Chairman, University Sports Committee, Dr. Rasheed Ojutiku expressed gratitude to the University Management for bankrolling the championship, adding that the championship has enabled the Sports Committee to discover new talents for the University among its staff.

Dr. Ojutiku thanked the Managements of Wema Bank and FUTMIN Ventures for supporting the University Sports Committee towards hosting a hitch-free football championship.

## NO NATIONAL DEVELOPMENT WITHOUT METALLURGICAL **ENGINEERING - PROF BALA**

s the Federal University of Technology, Minna hosts the National Executive Council meeting of the Nigerian Metallurgical Society (NMS), the Vice-Chancellor of the institution, Prof. Abdullahi Bala, FSSSN, has underscored the importance of Metallurgical Engineering in national development.

Prof. Bala stated this today at the Gidan Kwano Campus of the University when he received officials of the NMS led by the National President, Prof. Suleiman Hassan.

"We know that national development cannot actually be realised without capacity in metallurgy," said the Vice-Chancellor, adding that the fact that the country is still talking of how to complete the Ajaokuta steel project shows the sorry state it finds itself due to the selfish tendencies of some people that had been put in places of trust and a lack of appreciation of the role of metallurgy in national development.

He added that the University knows that it has a role to play in developing manpower to supply local content for the Metallurgy and Steel sector as the country cannot continue to rely on foreign countries, just as he stressed the need for Nigerians to take ownership of such national monuments as Ajaokuta steel project.

Prof. Bala therefore expressed hope that there would be a rethink to ensure that the steel and metallurgical sector make the expected contribution to national development.

The Vice-Chancellor noted that as the University's Department of Materials and Metallurgical Engineering is still young, the institution would have to rely on the Society in areas of manpower development and capacity building.

As a mark of appreciation to the University for its hospitality, the NMS donated copies of Journal of Metallurgy and Materials Engineering.

Earlier, NMS President Prof. Hassan told the Vice-Chancellor that the Society was in the University for its second quarter meeting of the year, hence the need to pay homage to the Chief Executive.

He thanked the University for the hospitality and wished the Vice-Chancellor success.

# ASSURES OF INCLUSIVENESS AS BORGU PROGRESSIVE ASSOCIATION VISITS

The Vice-Chairman said in their last visit, they sought for support in the areas of admission, employment and social responsibility and were still tabling the same request to the new helmsman.

He acknowledged the support of the immediate past Vice-Chancellor, Prof. Akanji and assured that they have put strategies in place to encourage their wards in Borgu to see the need for education and key into the technological sphere of life.

In a brief statement about the Association, Mal. Nasir pointed out that Borgu Progressive Association, Minna is a body of indigenes of Borgu resident in Minna aimed to foster unity among members and to promote their socio -cultural heritage.

According to him, the Association is registered with the Ministry of Youths and Sports Development while its registration with the Corporate Affairs Commission is on going.

In his response, the Vice-Chancellor, Prof. Bala welcomed and thanked them for the goodwill, prayer, support and positive remarks about the University.

The VC disclosed that he is particularly very passionate about issues concerning Borgu because the Mai Borgu was one of those that gave him all the necessary support when he was applying for the position of VC.

He, however, expressed displeasure that Borgu Emirate in general is not well represented, either in staffing or among students, because FUT, Minna is a Federal university located in Niger State and that Management will look into issues raised by the Association.

Prof. Bala who encouraged them to apply to FUT, Minna for available programmes assured that any citizen of Borgu kingdom that qualifies for admission, at Predegree, IJMB, first degree or Postgraduate levels, will be given admission.

He noted that Management was trying to encourage inclusiveness both in composition of students and staff.

The VC further revealed that the Management will give admission to at least 10 qualified candidates from Borgu for Pre-degree with waver of tuition fee.

Also in the area of corporate social responsibility, Prof. Bala disclosed that a computer training of secondary school students aimed at exposing and familiarising them with the use of computer, as most exams these days are computer-based, has just been concluded in Minna and that a similar one will be organised in New Bussa.

The VC praised them for their passion and interest in the development of their people.

"When we see people really interested in community development, we embrace them because community development is part of the mandate of the University so in trying to reach out to the communities, we don't use individuals but organisations," Prof. Bala said.

The Vice-Chancellor, Federal University of Technology, Minna, Prof. Abdullahi Bala, FSSSN gave this assurance during the 14th orientation programme for pre-degree and IJMB students for the 2017/2018 session held

recently at the CPES Hall, Bosso Campus.

The Vice-Chancellor pointed out that the student handbook had spelt out major issues concerning their studies while advising them to go through the book for guidance.

"You should refrain from all acts capable of ruining your academic sojourn in the University such as examination fighting, malpractice, cultism, assault, mongering, illicit drug peddling and racketeering of any kind," Prof. Bala warned.

Earlier in his welcome address, the Director of the Centre, Engr. Dr. Mohammed Saidu expressed his appreciation to the Vice-Chancellor for finding him worthy of being appointed to head the centre and pledged to improve on the landmark achievements already made by his predecessors.

The twin programmes run by the Centre, he said, had gained acceptability over the years and that students are drawn from all over the country.

"It is on record that all pre-degree and IJMB candidates who obtained the minimum score in both UTME and IJMB final examinations were absorbed into 100 and 200 levels respectively. We hope and pray that in 2018/2019 session admission of our students would be given priority." the Director reiterated.

Dr. Saidu also expressed hope for the commencement of studies at the Suleja Study Centre, expansion of the programmes that would include extra mural components and other commercial courses in the IJMB programme since it has more than 50 affiliated institutions that candidates could seek admissions from.

During the informative session, Deans of respective schools and Students Affairs presented a brief on the various academic programmes being run in their schools and students conduct in the University.

The Deputy Registrar (Academic), Hajiya Aisha S. Usman gave a rundown of the University Admission Entry Requirement, while Mrs. Eucharia Ezenwa Diugwu, Head of Guidance and Counselling Unit made a succinct presentation on passing through University Life and advised them not to hesitate to contact the Unit for proper guidance.

In his vote of thanks, the Secretary of the Centre, Comrade Abubakar Aliyu, noted that the orientation programme is an effort to ease transition to the main stream of the University and thanked everyone for attending.
