Thank you for submitting your manuscript, “**Effect of Working Capital Management on Performance of Supermarkets in Minna Metropolis, Niger State, Nigeria**” to *Baze University Journal of Entrepreneurship and Interdisciplinary Studies (BUJEIS)*. From the careful consideration of your manuscript by the journal's editorial board and a group of expert reviewers, the primary concerns expressed are that:

1. The author did not attempt to expose any valid gap,
2. Most recent citation cited is 2020 (2 previous works).
3. Poor presentation of references and wrong in-text citations.
4. The article did not offer any evidence of data analysed.
5. No discussion of finding to relate studies with previous empirical studies.
6. All highlighted issues on the manuscript should be reviewed and corrections effected.
7. Effect corrections made in the abstract and rearrange the keywords in alphabetical order.
8. Ensure proper in-text citations and appropriate referencing in compliance with APA 7th edition.
9. The author needs to structure the manuscript in this format: Introduction, Literature Review, Methodology, Results and Discussions, Conclusion and Recommendations.

Attached is a summary of the reviewed manuscript with some basic required edits that need to be applied before it can be accepted for publication. You are, required to resubmit as attachments,

- i. Your manuscript, *revised in line with the identified corrections*
- ii. *Plagiarism test conducted on the article (pdf) indicating 20% similarity rate result.* The plagiarism test may exclude the references.
- iii. *Evidence of N20,000 publication fee, subject to effecting all major corrections highlighted.*

We expect to receive the revised version with result of the 20% similarity rate on or before **April 5th, 2024**. The editorial board will thereafter review the manuscript to determine its suitability for publication. *Resubmitted manuscripts without cogent justification for not complying with the required edits will be rejected.*
